Integration of Animals into Settings

Calendar Description

This course provides an in-depth understanding of how to ethically and effectively integrate animals into 3 different types of settings. The 3 settings include: 1. Working as a mental health therapist with animals in an office setting, 2. Working in an educational setting and 3. Working in rehabilitation centres/facilities.

Rationale

This course provides the details for how to integrate animals into a variety of settings. Students are encouraged to review the content from the Law and Ethics course to ensure they are carrying forward the intricate ethical details for practitioners of AAI, for participants of AAI, for the animals in AAI and for the facilities/institutions in which AAI is carried out.

The main goal of this course is to provide details of why and how we would bring animals into our offices, classrooms and facilities. You are educated how to do this properly in these three settings and challenged to design your up and coming AAI program's documents (paperwork), evaluation methods, policies and procedures. You are expected to design your action plan and be prepared to outline the steps you need to take to begin to prepare for working in this field of AAI.
